



## **Lydiate Learning Trust Gender Pay Gap Report 2020**

Lydiate Learning Trust is required by law to carry out Gender Pay Reporting under the Equality Act 2010 (Gender Pay Gap Information) Regulations 2017. The overall gender pay gap is defined as the difference between the mean (average) or median (actual midpoint) hourly rate of pay of male and female employees.

At the snapshot date of 31<sup>st</sup> March 2020, the Trust has 286 employees who count as full pay relevant employees (the definition used for reporting gender pay). There are 204 females (71%) and 82 males (29%).

**The results of the statutory calculations are:**

### **1. Mean Pay Gap**

The difference between the mean hourly rate of pay that male and female full pay relevant employees receive is 13.4%.

### **2. Median Pay Gap**

The difference between the median hourly rate of pay that male and female full pay relevant employees receive is 13.4%.

### **3. Mean and Median Bonus Pay Gap**

No bonuses were paid to any member of staff for the reporting period.

### **4. The Proportion of Males and Females in Each Quartile Pay Band**

In all cases females represent the higher percentage. The middle quartiles follow the gender split of employees. In the upper quartile, males outperform their 29% gender split.
